PAC COMMITTEE

Dear Sisters and Brothers,

Caleb Frostman was elected to the 1st Sen. District as a result of the Special Election held in June. Thank you to all that worked in Caleb's behalf.

Candidates for the upcoming Fall Elections and AFL-CIO endorsements if any, are as follows:

Governor: Mahlon Mitchell, endorsed by AFL-CIO. There is a total of 15 Democrats and 2 Republicans, including Scott Walker, and 2 other, i.e. Independent, Green, etc. Lt. Governor: There are 3 Democrats, 2 Republicans, including incumbent Rebecca Kleefisch and 2 other.

Attorney General: Josh Kaul, Democrat and Brad Schimel, Republican, incumbent.

Secretary of State: There are 2 Democrats, and 2 Republicans. Incumbent Douglas LaFollette did not file papers.

State Treasurer: 5 Democrats, 4 Republicans and one other. Incumbent Matt Adamczyk filed Non-Candidacy Papers.

U.S. Senator: 2 Democrats, including Tammy Baldwin, endorsed by the Wisconsin AFL-CIO, and 5 Republicans.

1st Congressional District: 2 Democrats. Randy Bryce is endorsed by the Wisconsin AFL-CIO. A total of 5 Republicans. Paul Ryan is the incumbent, not running. 6th Congressional District: Dan Kohl, Herb Kohl's nephew, Democrat, and 2 Republicans, including incumbent Glenn Grothman.

8th Congressional District: 2 Democrats, including Beau Liegeois and one Republican, the incumbent Mike Gallagher.

Senate District: 1 Democrat, newly elected incumbent, Caleb Frostman, against 2 Republicans (including Andre Jacque).

4th Assembly District: Terry Lee, Democrat against incumbent David Steffen, Republican.

5th Assembly District: Matt Lederer, Democrat against Republican incumbent Jim Steineke.

6th Assembly District: 2 Democrats, incumbent Gary Tauchen, Republican and 1 other.

25th Assembly District: Jennifer Estrada, Democrat against incumbent Paul Tittl, Republican.

88th Assembly District: Tom Sieber, Democrat against incumbent John Macco, Republican.

89th Assembly District: Ken Holdorf, Democrat against incumbent John Nygren, Republican.

90th Assembly District: (was Eric Genrich's seat, who is now running for Green Bay Mayor). Staush Gruszynski, Democrat. No other opposition.

The Fall Primary will be held Tuesday, August 14th and the Fall General Election will be held Tuesday, November 6th.

According to the Kenosha News, Governor Walker may just lose his re-election bid over the condition of Wisconsin roads. There is enough contention around the state on that issue to cancel out anything positive most Republican voters may find in him.

The Kohl for Congress campaign reports that 6th Congressional District Glenn Grothman voted recently, along party lines, to slash Medicare and CHIP (Children's Health Insurance Program) by \$7 billion. Dan Kohl, who is running for that spot in the fall, says he would support the Medicare and CHIP funding.

On June 18th, the U.S. Supreme Court sent the Wisconsin Gerry-mandering case back to a lower court. This leaves the unfair maps in place for the Fall 2018 elections! Winnebago County is going to decide whether to place the redistricting issue as a referendum on the Fall ballot.

The Green Bay School Board voted down the Green Bay Police Department's recommendation to have retired policemen serve as armed guards at the public schools.

The Local PAC met on Tuesday, June 19th. We discussed the Special Election and the upcoming Fall election.

Don reported that Caleb Frostman visited our Hall and was impressed by our facility. We were able to give him a check for his campaign.

Don also said that Josh Kaul will be coming for a tour of our Hall and we will get him some campaign monies as well.

We also discussed Walker's appointment of Cathy Jess as Secretary of Department of Corrections. Jess had been the Deputy Secretary of the Department of Corrections. The Governor appointed Jess after Ed Wall, the former Secretary, stepped down over flack he got from accusing Attorney Brad Schimel of not doing his job in processing the back log of rape kits.

Our next PAC meeting is Tuesday, September 18th, 4:30 p.m., at the Hall. Please plan to attend as we prepare for the Fall Elections.
