BUSINESS MANAGER'S REPORT

Hello Brothers and Sisters:

I would like to follow up from last month's newsletter article on Pensions. I was informed this month that the National Electrical Benefit **Fund (NEBF) Trustees and National Employees** Benefit Board (NEBB) have made the following changes to the NEBF.

Fresh Start Amendment: The NEBF's actuary has certified that the NEBF currently has no "unfunded vested benefits" (UVB) and therefore no withdrawal liability as of December 31, 2023, and that it is not projected to have any future UVBs. In addition, the NEBF has approved an amendment to "fresh start" UVBs effective December 31, 2023, to ensure that no withdrawal liability will exist for any contributing employer in 2024 and that no withdrawal liability is projected as a result of the benefit improvements described herein.

One-Dollar Multiplier Increase: The pension benefit multiplier will increase from \$32.00 to \$33.00 per month for participants who retire effective January 1, 2025, or later. This will serve to provide a better benefit to attract and retain a workforce to build the future.

One-Time 13th Check: Recognizing their valuable contributions to the electrical construction industry, retirees with effective dates prior to January 1, 2025, will receive a one-time bonus payment on or around November 1, 2025, subject to a favorable actuarial opinion showing no withdrawal liability exists, and this action will not create any future withdrawal liability.

National Electrical Individual Benefit (NEIB): A new, optional benefit feature has been approved that, if adopted by local bargaining parties, would provide participants with an additional monthly retirement benefit and more personal planning opportunities. This benefit feature will be funded by employer contributions of at least \$0.50 per hour worked and provide participants with an additional monthly benefit equal to 1.5% of the contributions made on their behalf. The fund's actuary projects that the NEIB will further improve the NEBF's funded status over time. Optional, verbatim language will be made available in the near future for any area choosing to participate.

NEBF Contribution Rate: The "core" contribution rate will remain unchanged at 3% of gross labor payroll. As such, unless the local bargaining parties agree and adopt the optional NEIB, there will be no additional cost to contributing employers.

Here is a brief explanation of the change in benefits:

First, beginning on January 1, 2025, the new benefit calculator (on the NEBF website) will move from \$32.00 to \$33.00 for every year of service looking back for current members and moving forward for all the years of service in the NEBF. While any future increase is always a big deal, this higher amount is not only a raise for the years ahead, but retroactive for all your previous years of service.

Second. the National Electrical Individual Benefit (NEIB) is a new addition. This new benefit will need to be negotiated on a local level. The Trustees have developed the enabling language and will be detailed before the end of the year.

Third, the 13th check for current retirees once they have certification from the fund actuaries that the 13th check will not cause any future liability. If you have any questions, please do not hesitate to call.



February ended up being a busy month with career fairs and school visits. I attended Seymour High







If there is a negative balance there (i.e., -\$5.00), you should reduce your next payment by this amount. If there is a positive balance, there (i.e., \$2.40), increase your next payment.

CODE QUESTION OF THE MONTH

We all use a gas pump dispenser at a Uni-Mart/convenience store for fueling our vehicles. There always seems to be concern on a job site whether this dispenser is a Class 1, Division 1., or Class 1, Division 2 classification?



How is the method of Hazardous Classified Locations at the gas pump dispenser assigned?

According to the National Electrical Code per Section 514.3(B)(1), Class 1, Locations it states, Table 514.3(B)(1) shall be applied where Class 1 liquids are stored, handled, or dispensed and shall be used to delineate and classified motor fuel dispensing facilities and commercial garages.

Figure 514.3 gives detailed classified areas adjacent to dispensers. Per Table 514.3(B)(1) Class 1 Locations. The entire space within and under the dispenser pit or containment is Class 1, Division 1. Within 18 inches of the dispenser enclosure extending downward to grade level is Class 1, Division 2. Up to 18 inches above grade level out to a distance of 20 feet in all directions from the dispenser enclosure is Class 1, Division 2.

Using Table 514.3(B)(1) or Figure 514.3 should clear up any controversy.
